## Freedom of Information request

Thank you for your freedom of information request, which was received by the Human Tissue Authority (HTA) on 3 July 2023. Your email outlined the following request:

"Hi there, hope you're all well. I'd like to request under the Fol act data on how many bodies were released for public display in each of the last four calendar years, 2019-2022, broken down by year. And how many times the wrong body was released in each of those years, also broken down by year.

## Response

The HTA does not hold information regarding how many bodies were released for the purposes of public display.

With regards to the second part of your request, we have interpreted this to mean Human Tissue Authority Reportable Incidents (HTARIs) within the Post Mortem (PM) Sector.

The HTA holds information about HTARIs and routinely publishes quarterly reports on its website. The quarterly report details the nature and volume of the incidents reported, investigated and closed in the PM Sector, which includes the incident classification "release of the wrong body".

In considering your request, we have concluded that the information we hold on HTARIs is exempt from disclosure under Section 21 of the FOI Act. This is because the information is already reasonably accessible by other means.

Information in relation to HTARIs for the calendar years 2019 to 2022 can be found as follows:

- 1. Information from January 2019 to December 2019 is available in response to previous FOI requests. This information is published on the Freedom of Information responses page on the HTA website <u>HTARI FOI</u> and <u>HTARI FOI</u>
- Information from January 2020 to December 2021 is available in response to a previous FOI request. This is located on the <u>Freedom of Information</u> <u>responses page</u> on the HTA website.
